CANCELLATION POLICY: *Cancellation penalties apply to all guests in a stateroom and are assessed in the event of either partial or full stateroom cancellations.*

- \$75 fee per person for any correction involving names after booking is made. Name changes are subject to cancellation charges and any rate increases. Name must match passport.
- Travel Protection of \$145 (Balcony) \$125 (Oceanview) \$95 (Interior) is **non-refundable**.
- \$50 fee per stateroom for any cancellations made after Tuesday, November 1, 2011.
- 50% of total fee per stateroom for any cancellation made after January 31, 2012.
- Cancellations made after 5:00 pm March 1, 2012 are 100% Non-Refundable.

Travel Insurance:

Travel Insurance is only valid after your trip is paid in full. If canceling for a covered reason (ie. Medical), the trip must be paid for in full and you can then submit a claim for reimbursement. If canceling for a non-covered reason, refunds (or portions thereof) will be made only if canceling by the above dates.
